Instructions

Completing the form

1. Before you start, please read the [Guide for candidates](#).
2. Complete the form using either of the following the methods:
 - onscreen, by typing directly into the fields – make sure you **save** your completed form to your computer and open it in Acrobat or Acrobat Reader (do not fill in the form using a web browser).
 - printing the form and filling it in by hand – you may wish to **scan** your completed form for emailing (see step 5 below).
3. You **must complete** all of the questions in **Part A** (questions 1 to 10). The questions in Part B are optional.
4. Fill in the **Declaration** on the last page.

Submitting your registration

5. Submit your completed form before the **closing date**. Registration forms may be submitted by:

Closing dates

- Early bird registrations close on Thursday, 5 April 2018.
- The final date for registration and payment of the exam fee is **Sunday, 22 April 2018**. If you are posting your application, make sure you leave enough time for it to be delivered by Friday, 20 April 2018.
- No late registrations will be accepted. No late payments will be accepted. Candidates who have not paid the registration fee by the closing date will not be allowed to sit the exam.
- Cancellations after the closing date will not be accepted, except in accordance with our refund policy (see p 6).

Registration forms must be received no later than Sunday, 22 April 2018. The early bird cut-off date is Thursday, 5 April 2018.

Cancellations and refunds

Cancellations will be accepted, and any fee paid refunded (less \$100 administration fee), up to the closing date of 22 April 2018 only.

Once registrations have closed, cancellations will only be allowed in case of **illness or emergency**. If you need to cancel and can produce a medical certificate or other acceptable documentation, you may be entitled to a refund of your fee (less \$100 administration fee), at the discretion of the Accreditation Board.
